IV. Review and Approve September Meeting Minutes

- The GCPD reviewed the September quarterly meeting minutes.
 - A request was made to correct the misspelling of member name Tom O'Connor.
 - A motion was made by John Olson to approve the September quarterly meeting minutes as amended. The motion was seconded by Ben Barrett. The motion carried unanimously. See Motion Item 2.
- The GCPD reviewed the list of action items from the September 2019 quarterly meeting minutes.

VI. Updates on Disability Policy and Legislation – Fred Ludwig, Chief of Staff, Lieutenant Governor's Office



- Fred Ludwig provided comments on behalf of the Lieutenant Governor's Office.
 - The goal of the Governor's and Lieutenant Governor's office is to ensure sustainability and equity to allow everyone to have the opportunity to thrive and to live to their fullest potential.

 - It was recommended that an invitation to attend a quarterly meeting be extended to Secretary Andrea Palm in the Department of Health.
 - The GCPD could create and compile a new member orientation binder
