II. Meeting was called to order at 1:01 P.M. by Sandy Popp, Chairperson

III. Review and Approve the Agenda

IV. Review of Governor's Committee for People with Disabilities (GCPD) April Quarterly Meeting Minutes Including Action Items Related to Employment

- The Committee reviewed the list of action items from the April quarterly meeting minutes.

V. Public Comment on Issues Affecting People with Disabilities Relating to Employment

- John Olson (Mineral Point, WI) requested that the Committee consider transportation to and from a job as a crucial component of employment. People with disabilities using public transportation services consider transportation a necessary support to gainful employment. He feels current transportation agencies assigned to provide transportation are only doing the bare minimum and not adhering to expectations of contractual agreements. He requests that the Committee consider action to ensure these agencies are adhering to the laws.
- Discussion was had on options for including transportation related challenges and how it relates to employment for people with disabilities.
- Dan Idzikowski serves on both the employment and transportation subcommittees and will bring this request to the transportation committee for discussion on actions, and then make a recommendation to the executive committee for future consideration. See Action Item 1.

VI. Review and Discuss GCPD Work Plan July 1, 2018 – June 20, 2021

- The Committee reviewed the Employment section of the work plan.

- Discussion was had on each of the bulleted items listed under ‘Steps to achieve this goal’.

 - No formal updates have been directly communicated, but Nancy Leipzig provided the subcommittee with the information posted on the committee’s website.
 - The State Use Board 2018 Annual Report was approved.
 - The next meeting is scheduled for July 17, 2019.
 - Nancy Leipzig will share this information with other committee members. See Action Item 2.
 - The Committee will continue to monitor the CIE workgroup led by Division of Vocational Rehabilitation (DVR) and invite project leads and other CIE representatives to attend the GCPD June Quarterly meeting. See Action Items 3 and 4.
 - The Committee agreed to invite Ellie Hartman, PROMISE grant, to the Fall Quarterly meeting. Sandy Popp will contact Ellie and then provide availability to Executive Committee for a future quarterly meeting agenda item. See Action Item 5.
 - The Committee continues to monitor the Workforce Innovation and Opportunity Act (WIOA) implementation progress. Sandy Popp will reach out to Kathleen Enders for an update from DVR and request availability for a presentation at the GCPD June Quarterly meeting. See Action Item 6.
