IV. Honoring Dan Johnson

- Nancy Leipzig stated that GCPD did not do anything formal.
- Nancy Leipzig also stated that a proclamation from the Governor's Office was presented to Dan's family at his celebration of life by her, Ben Barrett, and Carrie Molke.
- Maureen Ryan said that Dan's family was getting technical assistance on items from skilled providers.
- Maureen Ryan also stated that a Go Fund Me account has been setup for Kathy. Kathy is hoping to raise enough money to give Drake money to go to Mongolia as Drake used money saved for this trip to help pay for the celebration of life for Dan.
- John Olson suggested that an award be created in Dan's name from all councils/committees which is focused on cross-disability advocacy. The award would only be given when earned/deserved, not necessarily on an annual basis.
 - o Ramsey Lee responded that this is a great idea and suggested that maybe the Committee should present an award to the family.
 - O Discussion was had among Committee Members and the Dan C. Johnson Excellence in Advocacy was recommended as a name for the award.
- Nancy Leipzig also said that the Committee could make a donation to Indigo Wings.
 - o Maureen Ryan stated that Indigo Wings was being dissolved.
- Nancy Leipzig said they will add this as an agenda item for the Committee's June quarterly meeting. Action Item 1.
- Nancy Leipzig said that the Committee should send emails to representative of other Councils to see what they think. Action Item 2.
- Lisa Sobczyk shared an idea from the Wisconsin Council on Physical Disabilities about having a plaque outside a conference room at the Department of Health Services near Dan's old office. The plaque could include information about Dan, the award, and names of those who are given the award.
